### Message from Mayor Rachel King

Greetings Amity,

Last month we had another great turnout for our City-wide clean up event. Thank you to Recology for their assistance and partnership and to all of you who participated. Over three large dumpsters were filled within 3 hours along with the electronics, metal, and yard wastes that were collected separately.

With spring now in full swing I'd like to share a few reminders:

Please be mindful and attend to any stagnant water that has accumulated on your property over this rainy season. Pooling water is hazardous to children and animals and provides a breeding ground for mosquitos and other insects.

Now is also a great time to clean up any newly emerging noxious weeds and vegetation. Clearing and removing vegetations such as blackberries, morning glory, and poison oak, among others; helps keep our city and neighborhoods looking their best. Early season upkeep also avoids these going to seed or spreading and helps reduce fire hazards as we heat up for the summer.

Lastly, the City of Amity code dictates that maintenance and upkeep of drainage ditches and sidewalks within the public right of way are the responsibility of the adjacent property owner. Keeping these areas unobstructed and clear is important to health and safety in our city. If you have questions or concerns regarding public right of way that abuts your property, please contact City Hall or Public works for guidance.

May is set to be a busy month for your City Council with our formal monthly meeting happening on the 1<sup>st</sup>, the first of Amity's annual budget meetings scheduled for May 8<sup>th</sup> and Council work session on May 15<sup>th</sup>. As seen in the upcoming event section, there are also opportunities to join in on an Amity Day, Tourism, or Historic Landmarks Committee meeting. As always, these meetings are open to the public and I encourage you to attend if you are able.

Remember your Mayor and Council are here to serve and represent you. Hearing from you directly is the best way to help us do well in our roles.

# What happens to my complaint?

Have you ever submitted a complaint to the city and wondered "where does my complaint go?" Whether it is a city code, city employee, or a neighbor, when a complaint is received, it gets distributed to the appropriate Department Head, City Administrator, Mayor, and the original gets kept in the file. The Department Head will be the person to contact the complainant for follow-up (if requested) and discuss solutions with the City Administrator. You may not always see the solution and sometimes the solution takes months, if not years, to come to fruition, depending on the complaint. Sometimes, it may take complaints from multiple households, like barking dogs for example, before law enforcement can address it. Sometimes it takes coordination with other agencies, like a county or state department.

Please understand that certain issues may take precedent over others; therefore, if you feel like your complaint is being overlooked, please let City Hall know. Your concern is our concern.

# Water System Flushing

The City of Amity Public Works Department has scheduled our periodic flushing of the water system to occur on May 30, 2024, weather permitting, starting at 8 pm and continuing throughout the night. This process stirs the settled sediment into the flowing water and not all of it is removed through the hydrants. The sediment that is not removed may enter your private water lines and, therefore, we advise you to run your COLD water using the outside faucets or bathtubs ONLY on the morning of May 31, 2024 until it runs clear and to exercise caution when washing laundry to avoid color damage.
